October 2025 Meeting is a Watercolor Demo

Heidi Nelson will be creating a half-sheet portrait demonstrating a simplified version of her signature technique of glazing – layering – to create luminous color that makes the subject's skin seem moist and glowing with life. The main emphasis of this demo will be to show this shortened process in two values/layers and still do the detail, resulting in a fresher portrait. She will share the color combinations and bring all the prep work that went into this series of five paintings. The subject will be an aged woman. The demo will show how to paint a face with wrinkles, but not get stuck in rendering them all.
